Board Approved COVID-19 Policy Effective February 26, 2021

We look forward to the time we can return to our former activities at the Resort before COVID-19. Until then, we need some rules and practices to keep our family and friends safe from the virus. As we understand more and more about COVID-19 it is clear that we need to live our lives as responsibly as possible and yet not be reactionary to unreasonable restrictions to our lives in the park. We also understand that there are a great variety of situations across the nation that are causing severe cases of the COVID-19 virus. In our park we have found that that we live in somewhat of a bubble with not a lot of new exposure to outside people. It is important that we provide guidelines for safety, but ultimately, we all need to assume responsibility for ourselves and our actions.

We wish to strive and keep this bubble intact and this policy is designed to do just that.

These guidelines are provided to members and visitors alike.

The following COVID-19 policy shall be in effect beginning February 26, 2021 until further notice:

1. Members and visitors returning or entering the park from extended absences greater than two weeks will be asked to read and sign a copy of our COVID policy. Visitors who refuse to do this will be refused admission to the park. To save time at check-in, this form is available for download on our website: fl-skp-resort.org.
2. For all new arrivals, members and guests are encouraged to maintain social distancing of 6 feet and wear masks for a period of 5 days after arrival from extended absences, when around others. Members and guests have a responsibility to respect other people in their choice of actions should they choose to observe more restrictive measures.
3. When inside the clubhouse, and in close proximity, people are encouraged to wear masks, for example when gathering to play cards. Using hand sanitizer is encouraged before and after club gatherings. When gathering around tables for other activities such as committee meetings, one chair separation is mandatory except for family members, and masks are optional.
4. The park leadership recognizes that outdoor activities are the safest when it comes to COVID-19 and encourages the various groups to gather in this venue whenever possible.
5. If you are diagnosed with COVID-19 it is required that you contact the front office with this information immediately and completely and totally isolate yourself and members of your household to your property until you have been tested COVID free. This information will be held in confidence and not disseminated by the board members or staff. Mail, trash collection and other services will be provide as needed by the staff and board members. Once you test negative for COVID*, the front office shall be notified and the isolation restrictions will be lifted. It is very important that close associates of the person diagnosed with COVID also be notified so they can be tested and take appropriate actions if they are diagnosed positive.
6. Common areas will be continued to be disinfected daily. In addition, cleaning stations will be in the common areas, i.e. rest rooms, laundry, library, kitchen, and hall where disinfectant will be available. We ask you to share the responsibility of disinfecting the area you were using before and after use.
7. The pool remains open with a 15-person limit.
8. In-person committee meetings can be held when social distancing can be maintained. Otherwise, virtual meetings are recommended.
9. Bottom line – we are not out of the woods yet with this COVID problem, but we in the Park are fortunate to have our bubble and we will strive to maintain the safety of this environment. Please use common sense and take precautions to keep yourselves and your neighbors safe.
